### Define the business's pay policy

Establish and communicate a clear payroll policy to all employees, outlining payment structures, benefits, and any other relevant information

### Onboard employees to payroll

Input employee data into the system, such as names, IDs, designations, departments, payment structures, working hours, benefits, and tax details. Payroll systems automate the subsequent calculations.

### Payroll Calculations

The system calculates:

**Gross Pay:** Total hours worked or agreed salary, overtime pay, and bonuses.

**Deductions:** Taxes, social security contributions, and any additional benefits offered by the organization.

**Net Pay = Gross Salary - Deductions**

**Gross Salary = Salary + Allowances + One-time benefits**

**Gross Deductions = Regular deductions (e.g., social security, medical insurance) + Legal deductions + One-time deductions**

### Compile tax reports and complete tax filings

Establish and communicate a clear payroll policy to all employees, outlining payment structures, benefits, and any other relevant information

### Payment Processing

Once calculations are complete, the system processes payments directly into employees' bank accounts.

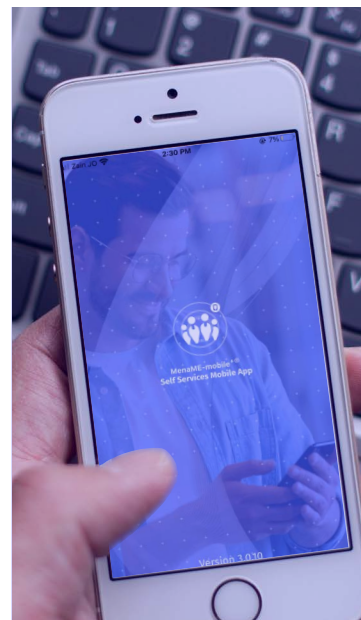
